Subject: Confirmation of Avian Influenza in Bankura, Nadia and Malda Districts of West Bengal.

In continuation of this Department's letters of even number dated 15th, 19th and 20th January, 2008, I am directed to inform that the samples collected from the following areas have tested positive for H5 strain of Avian Influenza in the rapid tests conducted at the High Security Animal Disease Laboratory (HSADL), Bhopal:

In this connection, it has been decided that in case of positive result for H5 strain of Avian Influenza by rapid tests in samples collected from areas bordering those already afflicted with H5N1 strain of Avian Influenza, culling and destruction of eggs and feed material etc. may commence immediately without waiting for confirmatory tests so as to control further spread of the disease without loss of time.

3. Accordingly, a series of strategic actions are now required to be taken immediately in the above areas. Such actions are to be taken by the Animal Husbandry and Public Health Departments. The strategy has been detailed in the 'Action Plan of Animal Husbandry for Preparedness, Control and Containment of Avian Influenza' revised and circulated by the Government of India in November, 2006 and other instructions/guidelines issued by the Government of India from time to time and also the 'Contingency Plan' circulated by the Ministry of Health and Family Welfare, Government of India.

4. It is requested that necessary actions contained in the Action Plan of Animal Husbandry referred to above (especially under part III) are initiated immediately by the State Government. These include declaration of infected and surveillance areas including actions to be taken in these areas (ban on movement of poultry and its products in infected area/closure of poultry and egg markets and shops within a radius of 10 kms. from the infected site/ban on movement of farm personnel/restricting access to wild and stray birds);

restricting access to the infected premises; destruction of birds; disposal of dead birds and infected materials; clean-up and dis-infection followed by sealing of the premises and issue of sanitization certificate; post operations surveillance; imposition of legislative measures etc. along with necessary measures laid down in the Contingency Plan of the Health Ministry, Government of India.

5. It has been decided that all poultry will be culled within a radius of 5 kms. of the foci. The foci of infection are as follows:-

(a) **Bankura District**

In addition to the culling strategy mentioned above, surveillance will be carried out over a further radius up to 10 kilometers.

6. It is the policy of the Government to compensate for loss of poultry on account of culling and destruction of birds. The rate for payment of compensation has also been indicated to the State Governments. The Government of India has conveyed the decision to

share costs of compensation on 50:50 basis with the State Governments and authorized State Governments to utilize funds available with them under the programme of 'Assistance to States for Control of Animal Disease' (ASCAD), which is a Centrally Sponsored Scheme. It may please be ensured that payment of compensation is immediate and simultaneous to culling.

7. A daily report on the control and containment operations may please be furnished to this Department by 2 P.M.

8. International Organizations will be notified by the Government of India at its level.

9. Surveillance throughout the State may be intensified to monitor further spread of infection, if any.
