Subject: Inspection/field visit of teams from DADF to different States


This is to inform that as per the directions of Secretary (ADF), the following teams from the Department have been formed for inspection/field visit to selected States as per following details:

The purpose of the inspection/field visit is to review the NLM Schemes that have been sanctioned during 2016-17, and where not yet implemented/started, schemes of 2015-16 may be reviewed. At State level, State Department to ensure high benefit District, Block, Village in terms of maximum assistance for an activity (e.g. poultry, sheep-goat, fodder development, etc) to be selected for the visits. Focus of visits is to be made on poor/ backward villagers, landless, SC/ST, BPL and women beneficiaries.

Dates for the field visits, other necessary arrangements, etc shall be coordinated by the State Department with the concerned Director, CPDO and RFS stations who shall liaise between DADF and the States and also assist in the inspection/field visit. Inspections/field visits are to be completed by February, 2017.
