NOTICE

Subject:- Non-operation of LOP holder deep-sea fishing vessels- issue of 'show-cause' notice- reg.

The undersigned is directed to refer to the Letter(s) of Permission (LOPs) granted by this Department to resource-specific deep-sea fishing vessels (DSFVs) (names mentioned in the list annexed) to conduct fishing operations in the Indian Exclusive Economic Zone (EEZ) in accordance with the Guidelines prescribed in this regard.

As per the said Guidelines, the operator companies/firms were required to maintain and operate the vessel(s) in good condition and pay for all operating and maintenance expenses including insurance, wages of crew's, surveys, etc. However, it has been observed that operators of the said LOP vessels have failed to operate their vessels since the last few years.

In view of the above, the LOP vessel operator companies / firms are hereby directed to furnish their clarifications / reasons for non-compliance of conditions in the matter to this Department within a fortnight, and 'show-cause' why action as deemed fit including cancellation of LOPs may not be taken against them.
