**ORDER**


**Subject: 16<sup>th</sup> Post Graduate Programme in Public Policy and Management at IIM Bangalore from 01.05.2017-reg**

Consequent upon his selection for participation in the 16<sup>th</sup> Post Graduate Programme in Public Policy and Management during 2016-17, at the Centre for Public Policy, Indian Institute of Management, Bangalore commencing from 1<sup>st</sup> May, 2017, Dr E Ramesh Kumar, Joint Secretary (IAS:MP-1999) is relieved of his duties from this Department w.e.f. the afternoon of 28.04.2017.
