3	Puducherry	Rs. 1.536 lakh (Rupees One lakh fifty-three thousand and six hundred only)
	Total	Rs. 9.256 lakh (Rupees Nine lakh Twenty-five thousand and six hundred only)

2. The other terms and conditions contained in this Ministry's earlier sanction letters while releasing funds remain unchanged.
3. The revalidated funds are to be utilized fully during the current financial year i.e. 2017-18 and no further revalidation of the funds under the scheme will be considered. In case the funds are not utilized during the current financial year, the same has to be refunded to this Department. Further release of funds under this scheme will be considered only on receipt of utilization certificate for the above-revalidated amount.
4. This sanction is issued in exercise of delegated powers and with the concurrence of Finance Division of Ministry of Agriculture, Department of Animal Husbandry, Dairying & Fisheries vide their Diary No. 1078/AS&FA/2016 dated 08.05.2017.


