**Sub: "Assistance to States for Control of Animal Diseases (Animal Disease Control)", a component of Centrally Sponsored Scheme 'Livestock Health and Disease Control' – Release of Central Assistance during the year 2017-18 to the NCT of Delhi State Government – regarding.**

Sir,

I am directed to refer to the subject cited above and to convey the Administrative Approval for the Centrally Sponsored Scheme "Assistance to States for Control of Animal Diseases (Animal Disease Control)" and sanction of the President of India for the payment of Grants-in-Aid amounting to Rs. 22.50 Lakhs (Rupees Twenty-Two Lakh Fifty Thousand only) to the NCT of Delhi State Government under "Assistance to States for Control of Animal Diseases" (ASCAD), a component of Centrally Sponsored Scheme 'Livestock Health and Disease Control' release of central assistance for the current Financial Year (2017-18). Out of Rs. 22.50 lakh (Rupees Twenty-Two Lakh Fifty Thousand only) Rs. 20 lakh (Rupees Twenty lakh only) to be utilised as compensation to owners towards culling of Glanders positive equines with the condition that matching 50% State share is to be provided by the NCT of Delhi State Government and rest Rs. 2.50 lakh (Rupees Two lakh and fifty thousand only) for surveillance (mobility).

2. The Grants-in-Aid of Rs. 22.50 Lakhs (Rupees Twenty-Two Lakh Fifty Thousand only) have been released in accordance with the approved pattern of financial assistance under the Scheme. The release to the NCT of Delhi State Government is subject to the condition that the next instalment for release will be considered only after obtaining the information relating to fund-utilization and submission of Utilization Certificate by the NCT of Delhi State Government.

3. The expenditure will be debited to the following Head of Accounts:

The payment of the amount during the Financial Year 2017-18 is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance letter No. 2(19)/ F.II/60 dated 09.10.1964. The actual figures of expenditure duly audited by the Accountant General may be furnished to this Ministry as early as possible.
5. The Grant-in-aid is sanctioned on the conditions that this will be utilized for the Scheme as specified in *para* 1 above and the estimate of the expenditure is treated as maximum and every effort is made to effect such economy as possible and also that expenditure is incurred in accordance with the ceiling approved by the Government of India under different Heads.
6. This Sanction is issued in exercise of delegated powers and with the concurrence of Finance Division of Ministry of Agriculture, Department of Animal Husbandry, Dairying & Fisheries vide their Diary No.2279/AC(B) dated 13.03.2018.
7. It is certified that the expenditure of Rs. 22.50 Lakhs (Rupees Twenty-Two Lakh Fifty Thousand only) have been duly noted in the Register of Grants at Serial No. 03 Page No. 49 of 2017-18.
8. The audited figures of expenditure of the current financial year as well as previous years may please be furnished.
