Sub: Release of Funds as second instalment to States for implementation of Foot and Mouth Disease Control Programme (FMD-CP), under Centrally Sponsored Scheme "Livestock Health & Disease Control" during 2017-18 –regarding.

Sir,

I am directed to convey the sanction of the President of India for the payment of Grants-in-Aid amounting to Rs.175.00 Lakhs (Rupees One Crore and seventy-five lakh Only) as Central Grants to the Department of Animal Husbandry & Veterinary Services of State Governments of Rajasthan, Uttar Pradesh, Bihar and Punjab as second instalment of 60% Central share for procurement of FMD vaccine and towards meeting expenditure on logistics for carrying out vaccination under Foot and Mouth Disease Control Programme (FMD-CP) during 2017-18 with the condition that matching 40% State share and is to be provided by the State Governments so as to carry out vaccination of all eligible animals as envisaged under the programme as per schedule of vaccination. The funds have been released to implement Special Component Plan for Schedules Castes as under:
