As per Entry 18 of Twelfth Schedule of the Constitution of India, regulation of slaughter houses and tanneries is in Powers, Authorities and responsibilities of Municipalities of the States. Department of Animal Husbandry, Dairying & Fisheries <b>neither has regulatory authority, nor maintains information on this.</b> Hence, Department have no information on the points sought by you. However, a list of State-wise number of registered slaughter houses from Basic Animal Husbandry Statistics 2016 is enclosed herewith.
3	Please provide the details of subsidy being currently provided to Slaughterhouses in India.	A copy of relevant Component of CSS-National Livestock Mission (NLM) from NLM Operational Guidelines is annexed.
5	Please provide details of total subsidy provided to Slaughterhouses in the year 2013, 2014 and 2015.	Nil information.
9	Is there any change in policy for Slaughterhouses in India after May 2014 till date	Before May, 2014, CSS- <b>'Establishment/Modernization of Rural Slaughterhouse'</b> was only for three States namely, Uttar Pradesh, Andhra Pradesh and Meghalaya and implementation was through National Bank for Agriculture & Rural Development (NABARD).  After May, 2014, <b>'Establishment/Modernization of</b>

		<b>Rural Slaughterhouse</b> is under the CSS-National Livestock Mission (NLM) as component and implementing agency is Panchayats/ Department of Animal Husbandry of the States. A copy of relevant Component of CSS-National Livestock Mission (NLM) from NLM Operational Guidelines is annexed.
