
Sir,

I am directed to refer to your letter No.P.7/2017-18/NLM-967 SAS Nagar dated 24/05/2018 from Director, Animal Husbandry requesting for revalidation of unutilized/balance fund of **Rs. 98,21,000/- (Rupees Ninety Eight Lakhs Twenty One Thousand only)** released by GOI vide Letter No. F.No.99-32/2014-NLM/Punjab dated 28/01/2015 to State Government of Punjab. Integrated Finance Department (IFD) of this department has agreed for revalidation of Rs.98.21 lakhs for utilization during 2018-19 for the Component Risk Management under the Sub-Mission "**Livestock Development**" of "**National Livestock Mission**" in favour of State Government of Punjab.

The above revalidation of Rs.98.21 lakhs is, however, subject to the conditions given below:-

1. The concerned State Government would utilize these funds during the current financial year 2018-19 and utilization Certificate, physical and financial achievements for the revalidated amount may be sent to this Department as per instruction of IFD failing which the refund would be sought by the Government of India.
2. The other terms and conditions will remain the same as contained in this Ministry's letter against which funds were released earlier to the State.
3. The concerned State Government would provide matching share, it any in the current financial year 2018-19.
4. This issue with the approval of AS&FA vide dairy No. 735/AS&FA dated 25/06/2018.


