**PUBLIC AUCTION NOTICE**

As recommended by Culling Committee held its meeting on 14.08.2024 It is proposed to conduct the Public Auction of uneconomical below performing animals (as per farm standards) (Cows & Heifers) on 19.09.2024 at 11.00AM at CEAH-CCBF, Campus-3, Hesaraghatta, Bengaluru-560088. The details will be available at the Central Cattle Breeding Farm, Hesaraghatta, Bengaluru during the office hours.

Note: The numbers may alter subject to decisions of the Auction committee.

**The other terms & conditions of the auctions will be as under:-**

1. The duly constituted committee will have all rights pertaining to this auction.
2. The interested bidders may register their names at the office of the Joint Commissioner, CCBF Hesaraghatta between 9.30 am to 11 am before the commencement of auction by depositing EMD of Rs.10,000/- (Rupees Ten Thousand Only & refundable) in the form of Cash. No deposits will be accepted after 11.00 am. This amount will be refunded only after completion of public auction. At no time the said amount will be refunded before or during the process of Public Auction. **At the time of registration, the bidders will have to submit a copy of their AADHAAR CARD for official records.** Tokens will be issued against Deposit and the same is Non-transferrable.
3. Only bidders, in whose name the amount is deposited, will be allowed and no other relative/friends/outsideers will be allowed inside the auction area of farm.
4. a) The successful bidders should deposit the total bid amount in the form Bharatkosh immediately after the bidding is over. (Admin office will facilitate in the depositing the Money through Bharatkosh).  
b) In case, if the successful bidder is unable to pay full amount within a stipulated time; his EMD will be forfeited and the selected animals will be automatically be treated as cancelled. No further claims in this regard will be entertained in future.
5. The successful bidders should collect their animals latest by 24 hours of bidding failing which Rs.500/- per day, per animal will be charged towards feeding and maintenance beyond 24 hours of closing of auction process.
6. **The auctioned animals should not be slaughtered for any reason.** An Undertaking to this effect "that the animals bought in public auction from this farm will not be slaughtered for any reason and that the said animals will be used for breeding purpose only" should be submitted to this office which should be issued by the Village Panchayat from the respective residential village of the bidder before taking delivery. If in case, the bidder fails to submit the said undertaking from the Village Panchayat/ Govt. Veterinary Officer of his residence, then the bid amount and the auction deposit amount will be forfeited.
7. The committee will have the rights on conduct of auction / bidding and withdraw the Auction/any animal in the interest of the Government without assigning any reason at any time.
8. Farmers/Entrepreneurs who own an animal Farm should submit the certificate from Govt. Veterinary Officer/ Village Panchayat of that area, that they have been registered/ allotted in the establishment of the farm. This is compulsory while bidding for more than 10 animals.
9. The animals may be examined with the prior approvals of the authorized Staff of CCBF Hesaraghatta in the allotted areas without disturbing other resident animals. In case, any individual mis-behaves/disturbed animals before or during auction/bidding period, his deposit amount will be forfeited and he will be forcefully removed from the farm premises.
10. After the bidding, the animals will be at the sole responsibility of the bidders only.
11. Other conditions, if any, will be made known prior to commencement/ during the process of auction.
