Sub: Central Sector Plan Scheme "DAIRY ENTERPRENEURSHIP DEVELOPMENT SCHEME"- the release of funds under Special Component Plan for Scheduled Caste (SCP-SC) to NABARD for its implementation in the country during the year 2014-15

Sir,

I am directed to refer to this Ministry's letter No.1-1/09-DP dated 8th May, 2014 conveying the administrative approval of Govt. of India for implementation of Central Sector Plan Scheme "DAIRY ENTERPRENEURSHIP DEVELOPMENT SCHEME" during 2014-15 through National Bank for Agriculture and Rural Development (NABARD) and to convey the sanction of President to release Rs 8,00,00,000 (Rupees Eight Crore only) as first installment of advance payment to NABARD under Special Component Plan for Scheduled Caste (SCP-SC) to meet their committed/ anticipated liabilities of claims of Scheduled Caste beneficiaries towards implementation of the scheme throughout the country during the year 2014-15

2. This amount is towards plan expenditure and should be utilized on the programme as per approved guidelines of DAIRY ENTERPRENEURSHIP DEVELOPMENT SCHEME and no deviation from the provisions of guidelines is permissible.

3. This release is further subjected to the following terms and conditions of General Financial Rules-2005.

a) NABARD will maintain subsidiary accounts of the amount. The Ministry of Finance has formulated standard formats for presentation of Final Accounts by Central Autonomous Organization. The Bank will maintain and present their annual accounts in the prescribed standard

b) The accounts of the Bank shall be open to the inspection by sanctioning authority and audit both by Comptroller & Auditor General of India under the provision of C.&A.G.(DPC) Act 1971 and internal audit by Pr.Accounts Office of the Ministry.

c) The certificate of actual utilization of amount for the purpose for which it is sanctioned will be submitted by the institute in form GFR-19-A after the close of financial year.

d) Performance-cum-Achievement report should be submitted after utilization of this amount.

e) The assets acquired wholly or substantially out of the government funds except those declared as obsolete and unserviceable or condemned in accordance with the procedure duly laid down in GFR shall not be disposed off without obtaining the prior approval of authority which sanctioned the grant.

f) NABARD agrees to make reservations for Scheduled Castes and Scheduled Tribes or OBC in the post or services under its control on the lines indicated by Government of India.
