Will the Minister of Fisheries, Animal Husbandry and Dairying

be pleased to state:

- (a) the date on which Animal Welfare Board of India (AWBI) was set up including the details of its jurisdiction;
- (b) the number of cowsheds recognised along with the amount of funds provided for their functioning and tin sheds and ambulances provided by the said Board during the last five years, year-wise, State-wise;
- (c) whether the applications for getting recognition and assistance received from the institutions of Tamil Nadu are lying pending with the Board; and
- (d) if so, the date from which these applications are lying pending including the reasons for their pendency along with the details thereof?

ANSWER

THE MINISTER FOR FISHERIES, ANIMAL HUSBANDRY AND DAIRYING
(SHRI PARSHOTTAM RUPALA)

- (a) The Animal Welfare Board of India (AIVBI) was set up on 19.03.1962 under Section 4 of the Prevention of Cruelty to Animals Act, 1960. The jurisdiction of AWBI is throughout the Country.
- (b) The Animal Welfare Board of India recognizes the Animal Welfare Organizations (AWOs) including Gaushalas as per the request made by those organizations. List of recognized Animal Welfare Organizations have been uploaded in the website at http://www.awbi.in/awbi-pdf/recolist_24032022.pdf. The Board has so far recognized 1566 Gaushala (cow-sheds) till date.
The Board provides financial assistance to the recognized Gaushala / AWOs under Shelter Grants, Regular Grant and Ambulance Grant. The State wise and year wise list of AWOs to whom the Board has provided assistance in last five years is at **Annexure I**.
