
OFFICE MEMORANDUM

(RR) dated 13.10.2015, before referring any proposal for framing/amendment in the Recruitment Rules, the proposed RRs are to be uploaded on the website of the respective Ministries/Departments for thirty (30) days for inviting comments from the stakeholders.

NOTIFICATION

New Delhi, the 2019.

G.S.R..... - In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules to amend the Department of Animal Husbandry Dairying and Fisheries, Animal Husbandry Commissioner Recruitment Rules, 2017 namely: -

1. Short title and commencement.- (1) These rules may be called the Department of Animal Husbandry and Dairying, Animal Husbandry Commissioner Recruitment (Amendment) Rules, 2019.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Department of Animal Husbandry Dairying and Fisheries, (Animal Husbandry Commissioner) Recruitment Rules, 2017, -

In column (11), for para below (b) (iii), the following para shall be substituted, namely:-

“(Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed 5 (five) years. The maximum age limit for appointment by transfer on deputation (including short-term contract) shall be not exceeding **fifty eight** years as on the closing date of the receipt of application.
